Investment strategy

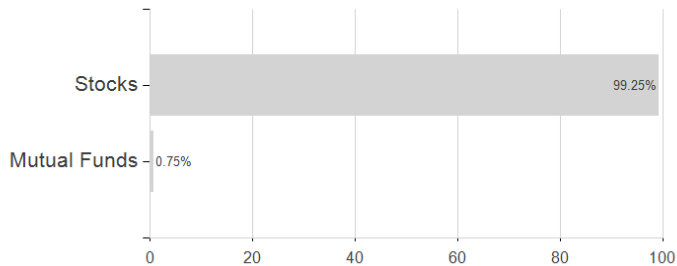

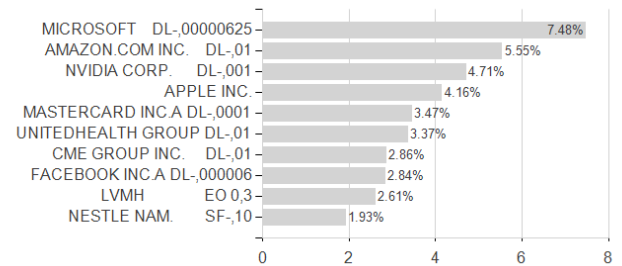
To achieve a return in excess of the global equity markets by investing primarily in companies, globally.

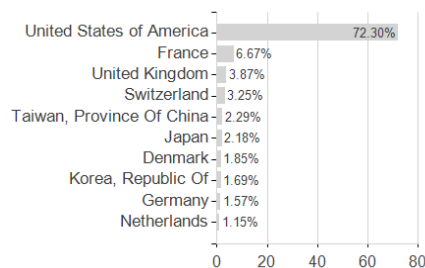

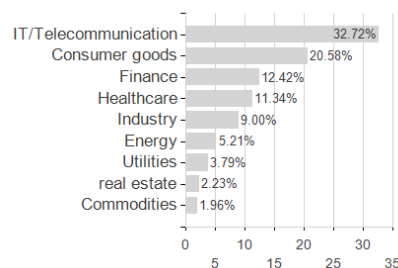
