## OBJECTIVES AND INVESTMENT POLICY

### Investment objective

The Fund seeks to increase the value of your investment over time through capital growth.

### Investment policy

Under normal market conditions, the Fund typically invests in equity securities of companies that are incorporated in China and are traded on the China A-Shares market. These companies may be of any market capitalization and industry.

For China-A Shares, the Fund may invest in all markets on which these Shares are traded, such as China Connect Scheme markets. The Fund may also invest in equities of Chinese companies traded in Hong Kong or other offshore markets. The Fund may also invest in China through a Renminbi Qualified Foreign Institutional Investor (RQFII) and Qualified Foreign Institutional Investor (QFII) programs, that may be held by the Management Company or an affiliate.

The Investment Manager seeks to select securities that it believes offer attractive Shareholder returns.

The Fund's expected exposure to CNY is 100%.

The Fund uses derivatives for hedging (reducing risks), efficient portfolio management and other investment purposes.

### Responsible Investing

The Fund is classified as Article 8 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

### Benchmark

MSCI China A Onshore Index (CNH) used for performance comparison.

The Fund is actively managed and the Investment Manager is not constrained by its benchmark. Please see the Fund's prospectus for more information.

### Hedged share class

This share class seeks to reduce the effect of exchange rate fluctuations between the Fund's base currency and the currency of the share class.

### Fund currency

The reference currency of the Fund is CNH.

### Share class currency

The reference currency of the share class is HKD.

### Distribution policy

This share class is a non-distributing share class. Income and capital gains derived from the Fund are reinvested.

### Redemption

Shares may be redeemed on any day on which banks in Luxembourg, Hong Kong, Shanghai and Shenzhen are open for business.

### Terms to understand

**China A-Shares:** Shares in mainland China-based companies that trade on Chinese stock exchanges such as the Shanghai Stock Exchange and the Shenzhen Stock Exchange. A-shares are generally available for purchase by mainland citizens in China; foreign investment in A-shares is subject to significant regulatory restrictions.

**China Connect Scheme:** A trading-linked program for Chinese securities developed by, among others, the Hong Kong, Shanghai, and Shenzhen stock exchanges.

**Derivatives:** Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

**Equities:** Securities that represent an ownership stake in a company.

**Other investment purposes:** In line with the Fund's investment objective and policy, means to gain exposure.

**SFDR:** Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector.

### What does this risk indicator mean?

This synthetic risk and reward indicator (SRR) scale rating indicates how the Fund may perform and the risk of losing some or all of your capital. Generally the potential for higher gains also means a larger risk of losses. The lowest category does not mean a risk free investment.

The above rating is an estimate, not a guarantee. It is calculated using industry-standard methods and is based on medium-term volatility (how sharply the Fund's actual or estimated share price has gone up and down over five years).

### Why is this Fund in this category?

The Fund is not guaranteed in capital. The Fund is invested in equity securities that can face sharp variations up or down and that can generate significant gains or losses.

### Risks materially relevant to the Fund but not adequately captured by the SRR:

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

**China Market risk:** The Fund will primarily invest in domestic securities of issuers located in China and so will be directly affected by volatility in securities markets in China and changes in the economic and political climate in China generally. The legal and regulatory framework for capital markets in China may not be as well developed as those of developed countries and entails additional risks.

**China Liquidity risk:** The Portfolio invests in China through a RQFII quota and so is subject to the liquidity risks associated with investment under a state-supervised quota system. The Portfolio may additionally invest in domestic Chinese equity markets through the Shanghai-Hong Kong Stock Connect Scheme, and so is subject to the custody, execution and liquidity risks of investing in securities via this newly established market infrastructure.

**Counterparty risk:** If an entity with which the Fund does business becomes insolvent, payments owed to the Fund could be delayed, reduced, or eliminated.

**Focus risk:** The Fund may have significant exposure to a single industry sector or country, and could be more sensitive to events impacting that sector or country.

**Liquidity risk:** Certain securities could become hard to buy or to sell at a desired time or price.

## CHARGES

The charges you pay are used to pay the cost of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

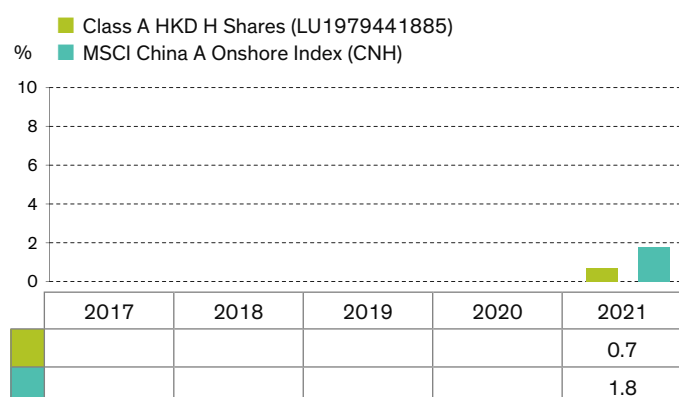
