## What is this product?

#### Туре

This product is an investment fund.

#### Term

The Fund is established for an unlimited duration, with the possibility for the Board of Directors to decide the termination of the Fund at its sole discretion.

#### Objectives

Candriam Global Dividend Equities belongs to the category of Single Manager Funds.

The Fund seeks to increase the value of its assets over the long term by investing predominantly in transferable equity securities such as equities, other equity shares such as co-operative shares and participation certificates issued by, or warrants on transferable equity securities of, companies which are located worldwide (including emerging markets) and from any economic sector. The minimum asset allocation in such securities on a consolidated basis (direct and indirect investments) will be of 60% of the Fund's net assets. Moreover, the minimum Fund's investment in equity securities will be of 75% of the net assets of the Fund.

The following restrictions will apply to the Fund:

- Maximum exposure to emerging markets: 50%
- Maximum exposure to small caps & midcaps: 50%

Investments in debt securities do not exceed 15% of its net assets.

The Fund may invest for maximum 10% of its net assets in funds that have been selected in accordance with a number of qualitative and quantitative criteria.

The Fund may recourse to non-complex positions on derivative financial instruments or to derivative financial instruments used for hedging purposes only.

This Fund is actively managed and is compared to the MSCI AC World TR Net for performance and risk level indicator purposes. However, the reference to this index does not constitute any objective or limitation in the management and composition of the portfolio and the Fund does not restrain its universe to the index components.

Therefore returns may deviate materially from the performance of the reference index.

The base currency of the Fund is EUR.

Income is systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

#### Intended retail investor

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.



## What are the risks and what could I get in return?

## What happens if ABN AMRO Funds Candriam Global Dividend Equities is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

#### **Costs over time**

#### **Recommended holding period: 5 years**
