What is this product?

The product is a share of the sub-fund Templeton Global Smaller Companies Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

 equity securities issued by smaller companies (i.e. with a market capitalisation within the range of the market capitalisations of companies included in the MSCI All Country World Small Cap Index), located in any country, including emerging markets

The Fund can invest to a lesser extent in:

- equity securities issued by companies of any size located in any country
- · derivatives for hedging and efficient portfolio management

The investment team uses in-depth analysis to select individual equity securities that it believes are undervalued and will provide the best opportunities for increased value over the long term.

The benchmark of the Fund is the MSCI AC World Small Cap Index-NR. The Fund uses a benchmark index to define small caps as the range of acceptable market caps at initial purchase and also as a reference for Investors to compare against the Funds' performance. The Fund is not obliged to hold any of the benchmark constituents and may indeed invest up to 100% of its net assets outside the benchmark.

Share Class Policy

For the distribution share class shown in this document, dividend income is distributed to shareholders.

Intended retail Investor

The Fund may appeal to investors looking to capital appreciation by obtaining exposure to equity securities issued by small-cap companies worldwide and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs.
