Objectives and Investment Policy

The objective of the Fund is to outperform its Benchmark investing in debt securities.

The Fund shall invest at least 70% of its net assets in debt securities of issuers incorporated or having their registered office in Central and Eastern Europe (CEE).

The Fund shall invest at least 51% of its net assets in securities with Investment Grade Credit Rating. Investment Grade Credit Rating is credit rating from AAA to BBB- for Standard & Poors or from Aaa to Baa3 for Moody's or from AAA to BBB- for Fitch or an equivalent credit rating by a recognised credit rating agency or an equivalent credit rating as deemed by the Investment Manager.

The Fund may invest up to 49% of its net assets in securities with Sub-Investment Grade Credit Rating, or, that are in the opinion of the Investment Manager, of comparable quality. The Fund may also hold distressed/defaulted securities (being securities having a rating CCC+ or below from S&P or any equivalent grade of other credit rating agencies) as a result of the potential downgrading of the issuers. Distressed/defaulted securities will be sold as soon as possible, under normal market circumstances, and in the best interest of shareholders. In any event, the proportion of distressed/defaulted securities due to a downgrade will not amount to more than 5% of the fund's net assets. If no rating is available, then an equivalent credit rating, as deemed by the Investment Manager, may be used.

The Fund may invest up to 30% of its net assets in money market instruments, bank deposits and bonds of European issuer.

A maximum of 25% of the total assets of the Fund may be invested in convertible bonds. The Fund may hold equities following the conversion up to 5% of its net asset.

None of the net assets of the Fund may be invested in equities and other participation rights.

The Fund may also invest into "Rule 144A" and/or Regulation S securities, which in accordance with US Law are not registered with the US Securities and Exchange Commission (SEC).

The Fund is actively managed and references the Benchmark by seeking to outperform it. The Investment Manager has full discretion over the composition of the Fund's portfolio and there are no restrictions on the extent to which the Fund's portfolio and performance may deviate from the ones of the Benchmark.

The Fund may use financial instruments and derivatives for hedging purposes, for efficient portfolio management purposes and for investment purposes.

The Fund is open-ended. You may redeem shares of the Fund on any Luxembourg business day.

The Share Class makes a dividend payment.

The Benchmark of the Fund is the 24.25% ICE BofA Merrill Lynch 1-4 Year Hungary Government Index - Total Return Index Value + 33.95% ICE BofA Merrill Lynch 1-4 Year Poland Government Index - Total Return Index Value + 14.55% ICE BofA Merrill Lynch Romania Government Index - Total Return Index Value + 24.25% ICE BofA Merrill Lynch 1-4 Year Czech Republic Government Index Total Return Index Value + 3% ICE BofA Merrill Lynch 0-1 Year Euro Government Index.

Risk and Reward Profile



This indicator represents the annual historical volatility of the Fund over a 5-year period. Its aim is to help investors understand the uncertainties attached to gains and losses that may have an impact on their investment.

The Fund's diversified exposure to emerging debt markets and to interest rate and foreign currency risks explains its classification in this category.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Credit Risk: The Fund invests a substantial portion of its assets in bonds. The issuers may become insolvent, whereby the bonds may lose a major part of their value or their value entirely.

Liquidity Risk: Risk related to a limited market activity that could not allow the Fund to sell or buy underlying investments in suitable conditions.

Counterparty Risk: The Fund primarily concludes derivatives trades with various contracting parties. There is a risk that counterparties may no longer be able to honour their payment or settlement obligations.

Geopolitical Risk: Risk related to investments in geographic areas or sectors that may be sensitive to any event of economic, geopolitical or regulatory nature or any other events beyond the control of the Management Company that could expose the Fund to losses.

Operational Risk and Depositary Risk: The Fund may fall victim to fraud or other criminal acts. It may also incur losses due to misunderstandings or errors by employees of the management company, the depositary or external third parties. Finally, its' management or the custody of its' assets can be adversely affected by external events such as fires, natural disasters etc.

Specific Securities-Related Risk: The fund may invest in securities rated below investment grade, which present greater risk of loss to principal and interest than higher-quality securities, and securities issued pursuant to Rule 144A and/or Regulation S.

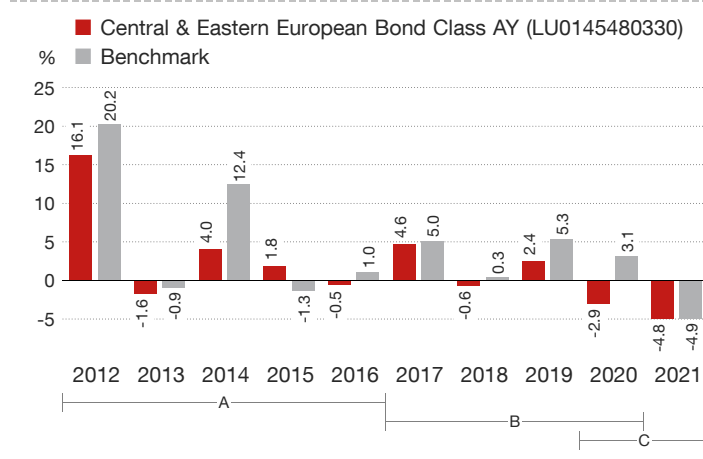
