The software used performs calculations on the basis of more than the two decimal places displayed. Minor discrepancies cannot be ruled out due to further calculations using published results.

The value of a unit is calculated by dividing the entire value of the investment fund inclusive of its income by the number of units. The total value of the investment fund is calculated on the basis of the current market prices of the securities, money market instruments and subscription rights in the fund plus the value of the fund's financial investments, cash holdings, credit balances, receivables and other rights net of its payables. That value will be calculated by the custodian bank.

The net assets are calculated in accordance with the following principles:

- a) The value of assets quoted or traded on a stock exchange or other regulated market shall be determined, in principle, on the basis of the most recently available price.
- b) Where an asset is not quoted or traded on a stock market or another regulated market or where the price for an asset quoted or traded on a stock market or another regulated market does not appropriately reflect its actual market value, the prices provided by reliable data providers or, alternatively, market prices for equivalent securities or other recognized market valuation methods shall be used.

Raiffeisen KAG calculates performance based on the published fund price, using the OeKB methodology. Individual costs – such as transaction fees, the subscription fee (not exceeding 5.00 %), the redemption fee (not exceeding 0.00 %) or custody charges of the investor – and taxes are not included in the performance calculation. These would reduce the performance if they were included. Past value is not a reliable indicator of the fund's future performance.

Fund investment policy report

Kathrein Mandatum 70 is a mixed fund of funds. The lion's share of the bond segment and the large cap stock markets in Europe and the USA are covered via Kathrein funds. Moreover, investments are made in Kathrein Capital Management funds and in passive index products.

One of the key aspects of the management of the Kathrein bond funds is active duration management. Selection in the Kathrein equity funds is based on corporate performance indicators, analysts' estimates and technical indicators.

The currency risk against the US dollar, which arises from investments in equities and US government bonds, is partially hedged. This hedge can be increased or reduced via a currency model which factors in parameters such as purchasing power parities, interest rate developments and trends. Models developed by Ned Davis Research and Kathrein manage the tactical control of the equity exposure. Between early December 2022 and mid-March 2023, the equity exposure was raised on tactical grounds. Following a tactical reduction between mid-March 2023 and early May 2023, the equity exposure was tactically raised again from early May to the end of the reporting period.

Alternative investments, among them Kathrein Max Return, are added to reduce the overall risk associated with the low stock market correlation.
