#### Objective

To generate income and the long term growth of your investment

#### **Main Investments**

• At least 70% of the Fund's investments will be in fixed income securities (e.g. bonds) and fixed income securities which convert into equity when they mature.

#### **Investment Policy**

- Issuers may be based anywhere, and investments may be in any currency.
- Investments shall not knowingly include any company which generates revenues from: the manufacturing or production of controversial weapons, civilian firearms and tobacco; or business activities involving mining, extraction or production of fossil fuels. The details of the above exclusions and positive screening can be found on the company's website.
- The Fund will measure its performance against the Refinitiv Global Convertible Index Global Focus Hedged USD (the "Benchmark"). The Fund is actively managed and is not designed to track the Benchmark. Therefore, the management of the Fund is not constrained by the composition of the Benchmark.

#### Other Information

- The Fund may invest up to 30% of its assets in other fixed income securities that do not meet the above criteria. Also the fund may invest in equities and warrants.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ('Financial Derivative Instruments' section) for more details.
- Income will be included in the value of your shares.
