# What is this product?

The product is a share class of the sub-fund Templeton China Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an openended investment company with variable capital (SICAV), qualifying as a UCITS.

# Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

#### **Objectives**

# **Investment Objective**

The Fund is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to increase the value of its investments over the medium to long term.

#### **Investment Policy**

The Fund pursues an actively managed investment strategy and invests mainly in:

- · equity securities issued by companies of any size located in, or doing significant business in, China, Hong Kong and Taiwan
- China A-Shares (through Shanghai-Hong Kong Shenzhen-Hong Kong Stock Connect, through qualified foreign investor (QFI) portfolios, UCIs and any permissible means available to the Fund under prevailing laws and regulations) and up to 20% of its net assets in China B-Shares

The Fund can invest to a lesser extent in:

- · equity securities for which the principal markets for trading are China, Hong Kong and Taiwan, or whose performance relates to assets in, or currencies of, those countries
- · equity or debt securities issued by companies of any size located in any country, including other emerging markets

· derivatives for hedging and efficient portfolio management

The investment team uses in-depth financial analysis to select individual securities that it believes will provide the best opportunities for increased value over the long term.

The benchmark of the Fund is the MSCI China 10/40 Index-NR - Linked. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

For the distribution share class shown in this document, dividend income is distributed to shareholders

#### Intended retail Investor

The Fund may appeal to investors looking to capital appreciation by obtaining exposure to equity securities issued by companies located in China, Hong Kong or Taiwan and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

# What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.I. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

#### What are the costs?

#### **Costs over Time**

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
