Investment strategy

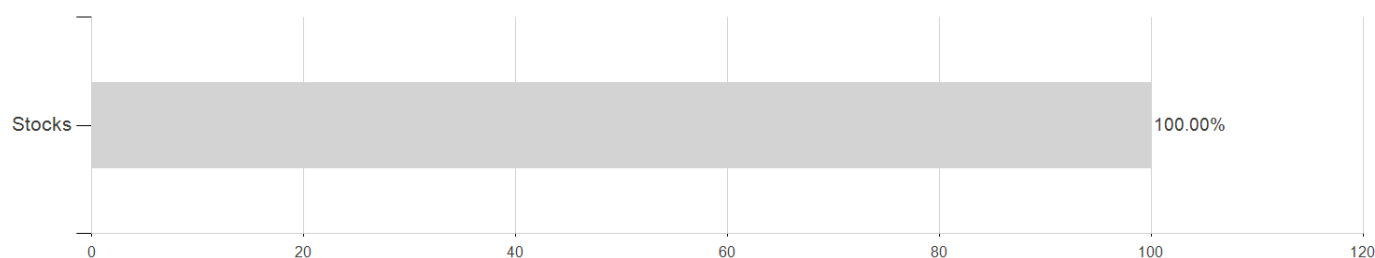

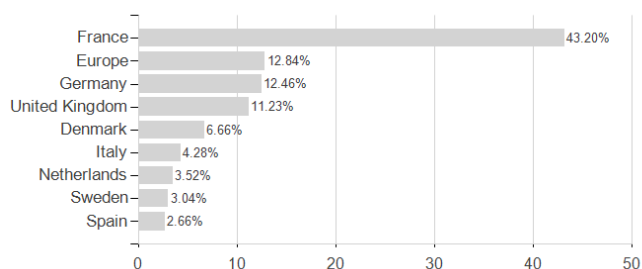
