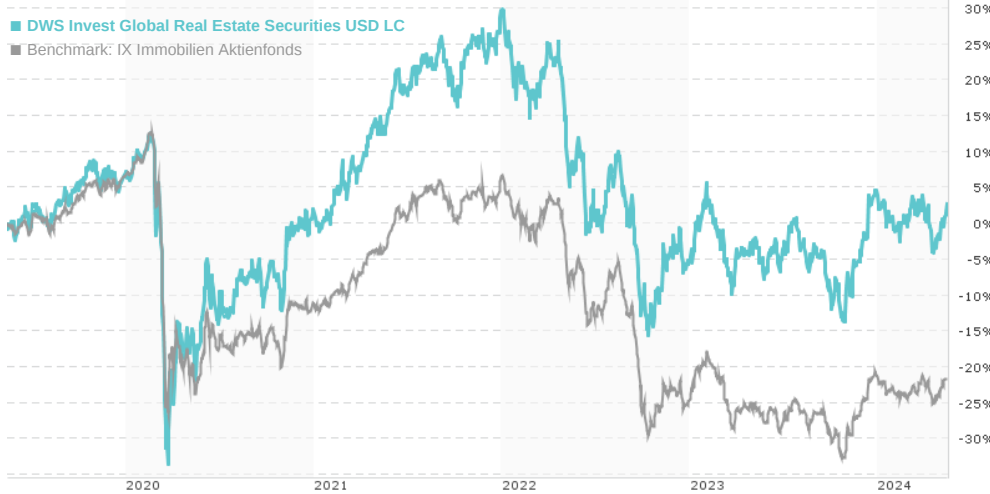

Investment strategy

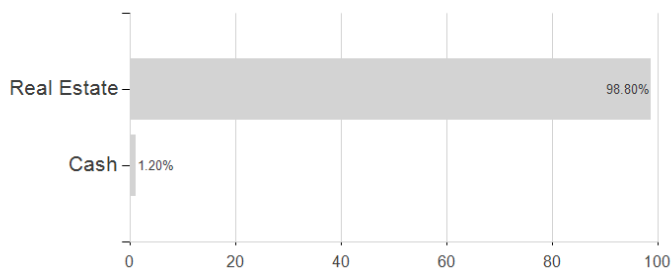

Investment goal

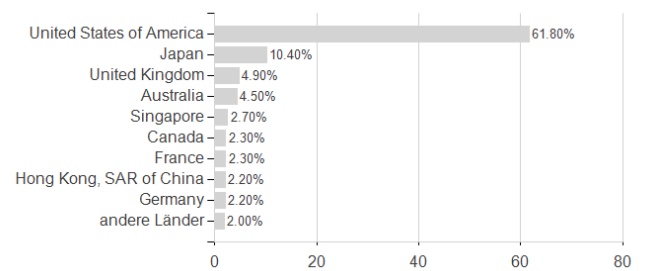

Assessment Structure

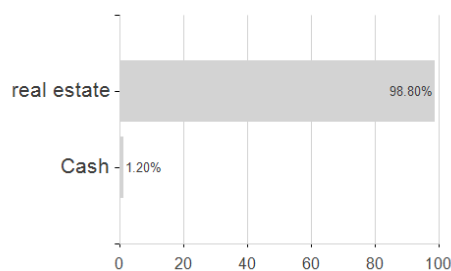

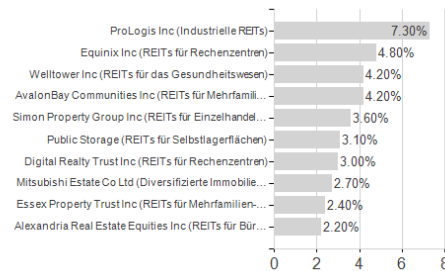
