Investment strategy

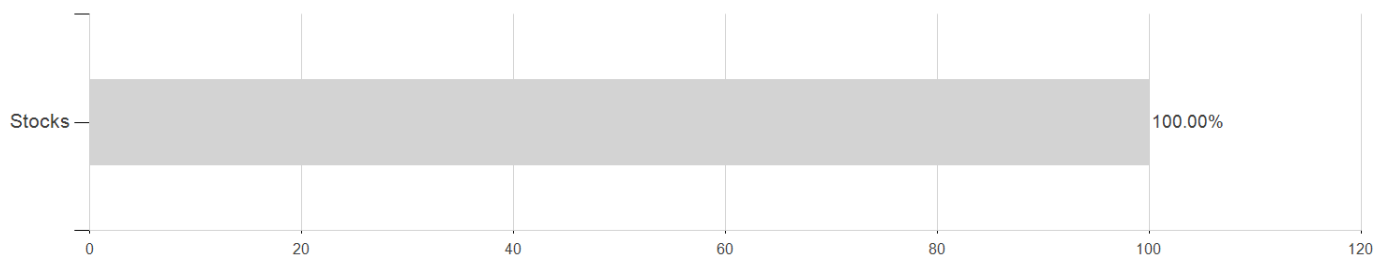

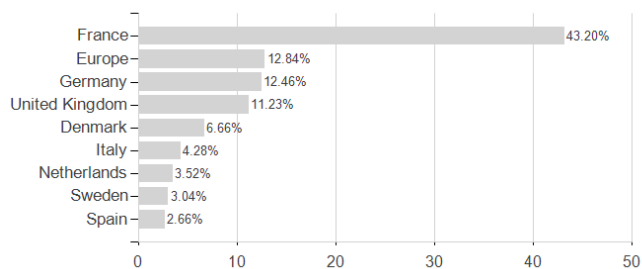
