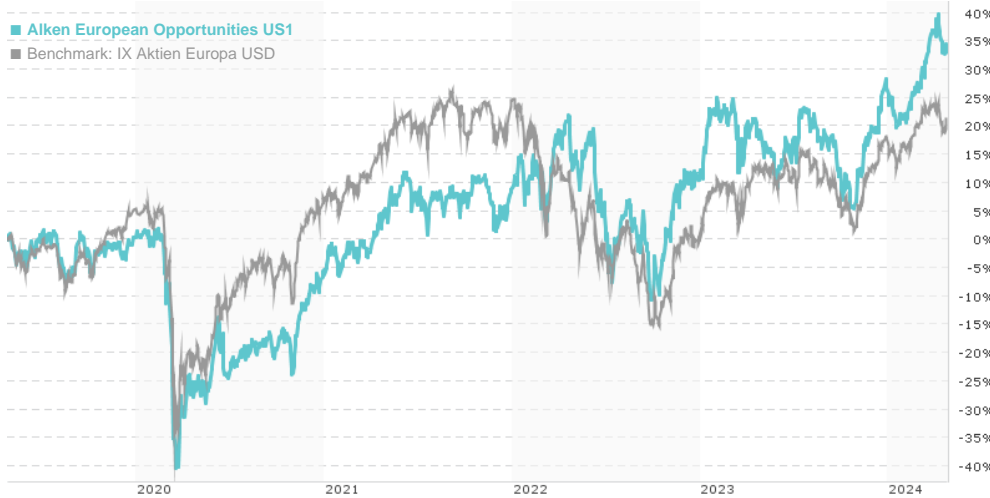

Investment strategy

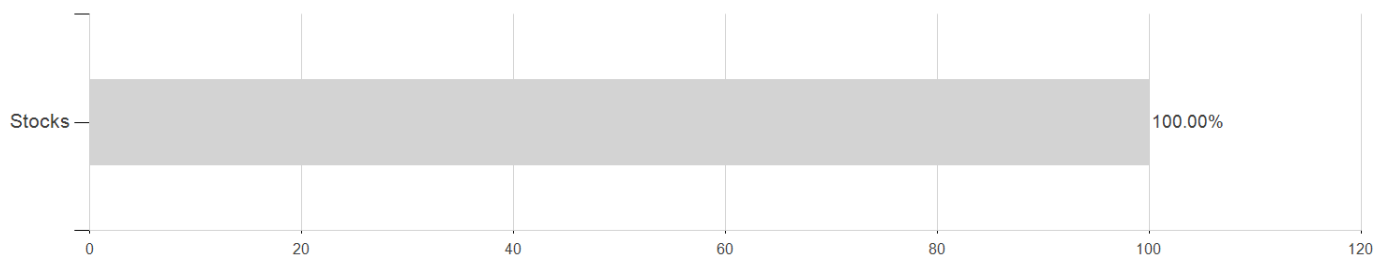

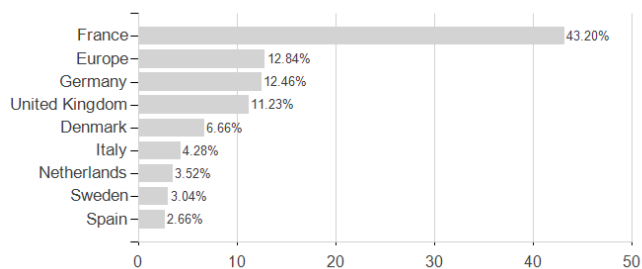
