### Investment strategy

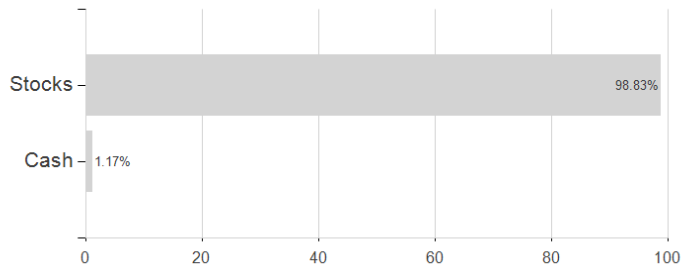

### Investment goal

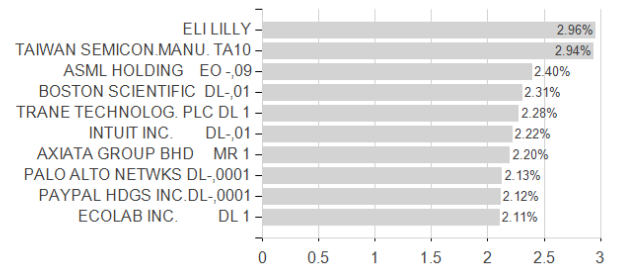

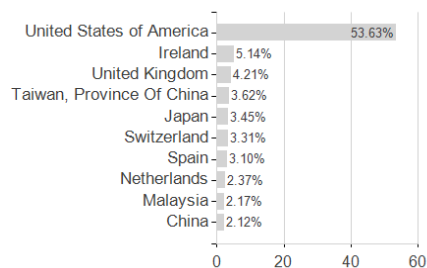

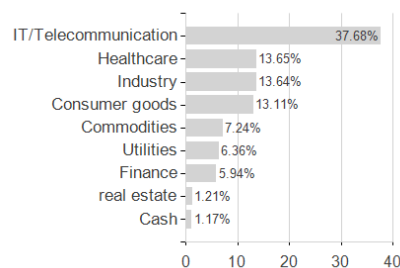
