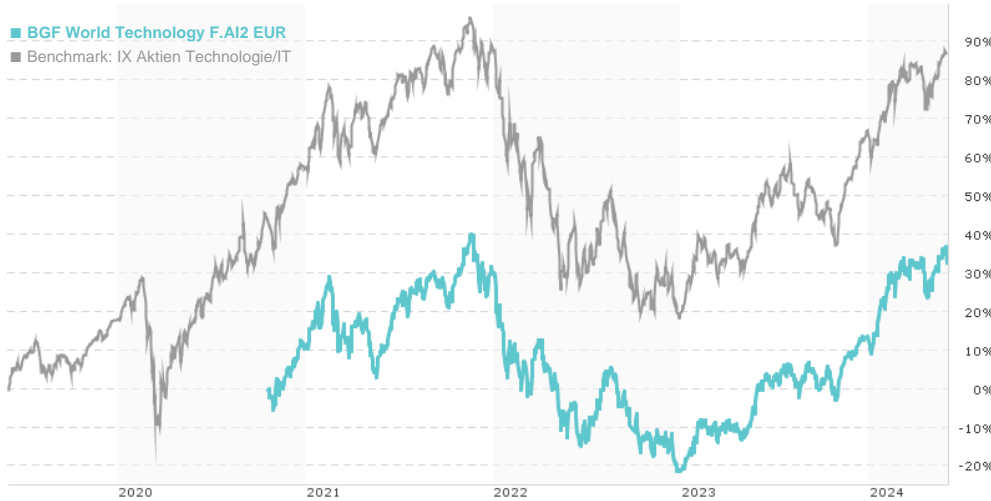

### Investment strategy

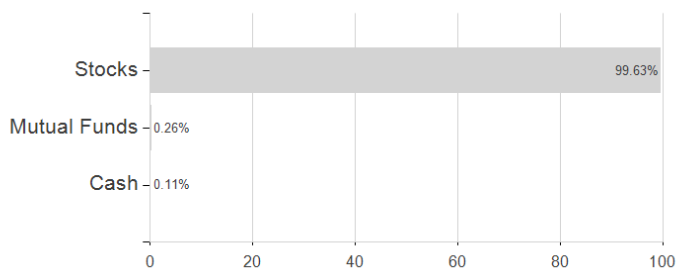

### Investment goal

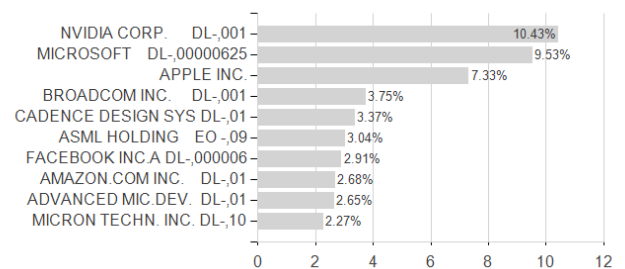

### Assessment Structure

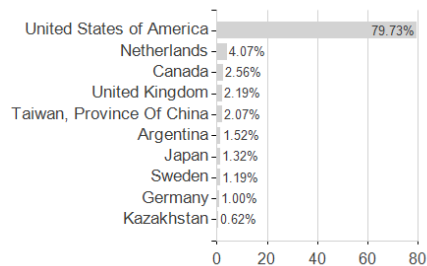

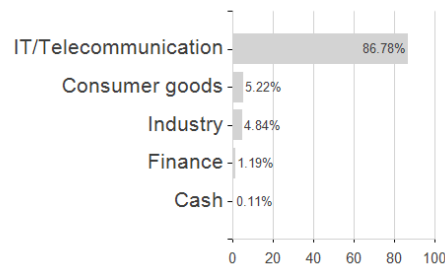
