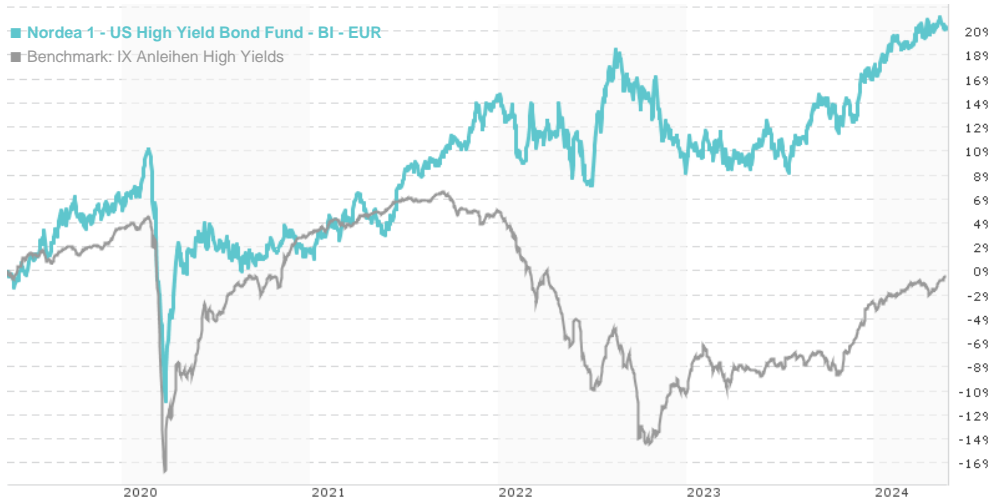

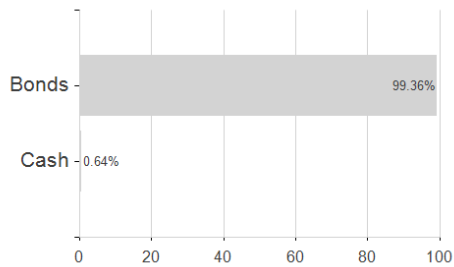

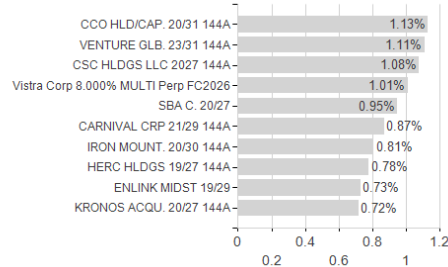

Assessment Structure

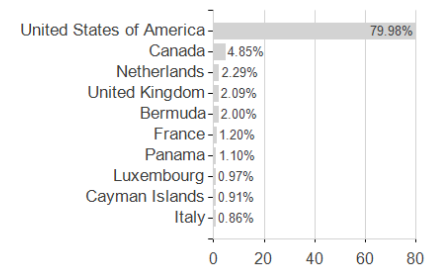

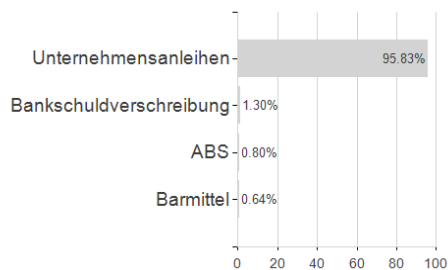

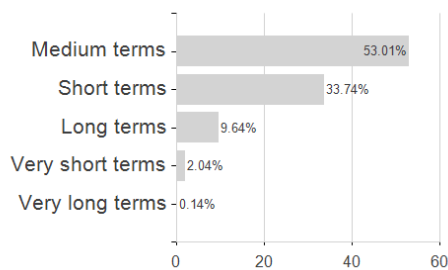
