OBJECTIVES AND INVESTMENT POLICY

Investment objective

The Fund seeks to increase the value of your investment over time through capital growth.

Investment policy

Under normal market conditions, the Fund typically invests at least 80%, and not less than two thirds, of its assets in equity securities of companies that are organized, or have substantial business activities, in the US.

The Investment Manager intends to build a comparatively concentrated, high conviction portfolio of securities of large-capitalization companies (typically 40-60 companies) that it believes are of high quality and superior long-term growth characteristics.

The Fund may be exposed to any currency.

The Fund uses derivatives for hedging (reducing risks) and efficient portfolio management.

Responsible Investing

The Fund is classified as Article 8 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

Benchmark

Russell 1000 Growth Index used for performance comparison.

The Fund is actively managed and the Investment Manager is not constrained by its benchmark. Please see the Fund's prospectus for more information.

Fund currency

Share class currency

The reference currency of the share class is SGD.

Distribution policy

This share class is a non-distributing share class. Income and capital gains derived from the Fund are reinvested.

What does this risk indicator mean?


