

Objectives: The investment goal of the Fund is to achieve an above average risk/return profile by investing in Asset-Backed Securities ("ABS") with low volatility and minimal correlation to traditional investments. ABS securities have to be rated Investment Grade by at least one of the leading Rating Agencies (S&P, Moody's or Fitch) at the time of issuance, ABS securities with no initial investment grade rating that have been upgraded to investment grade, need to be investment grade by at least one of the leading Rating Agencies (S&P, Moody's or Fitch) at the time of purchase. ABS are securities which are typically issued by a special purpose company ("SPV") on the occasion of the securitization of assets. An asset securitization is the transformation of a pool of cash-flow generating assets into tradable securities. The purchase of the asset pool by the SPV is financed through the issuance of securities. Interest and principal payments on the securities are thereby exclusively derived from cash flows generated by the SPV's assets. The assets of the SPV are managed by a specialized portfolio manager and are comprised of diversified portfolios of loans, bonds, mortgages or similar credit instruments.

Intended retail investor: In the member state of origin, the product is intended for professional and private investors with a long-term investment horizon, informed experience and who are able to bear a full financial loss. The product may be used for capital appreciation.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product until 6 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high. This rates the potential losses from future performance at a medium-high level, and poor market conditions are very unlikely to impact our capacity to pay you.

Performance-Scenarios:


Recommended holding period: 6 years
