What is this product?

Туре	The product is an investment fund in the form of a fonds commun de placement (FCP) pursuant to Part I of the Luxembourg Law of 17 December 2010 on undertakings for collective investment ("Law of 2010") and pursuant to Directive 2009/65/EC of the European Parliament and of the Council of 13 July 2009 on the coordination of laws, regulations and administrative provisions relating to undertakings for collective investment in transferable securities.
Term	The term of the Fund is unlimited, so there is no maturity date. The Fund may be dissolved and liquidated under the specific circumstances set out in the Management Regulations.
Objectives	The Fund is actively managed. The investment objective of the Fund is to achieve the greatest possible capital appreciation. In order to achieve this aim, at least 51% of the fund's assets is invested in Micro Cap shares of European issuers. European issuers are those whose head office, main stock exchange or business operations are in Europe, i.e. the country of risk is Europe. The fund invests primarily in high-growth, small-sized companies (Micro Caps) with a market capitalisation of up to EUR 1 billion. The fund aims to outperform its benchmark MSCI Europe Micro Cap Index. A maximum of 10% of the net fund assets may be invested in contingent convertibles. A maximum of 20% of the net assets may be invested in interest-bearing securities. A maximum of 5% of net fund assets may be invested in real estate investment trusts (REITs) which are security-grade. In accordance with Article 41(1)(e) of the Law of 17 December 2010, a maximum of 10% of the net fund assets may be invested in order to hedge positions or to increase its returns. The benchmark for the fund is: 100% MSCI Europe Micro Cap NR (EUR). The benchmark index for the fund is determined by the Manufacturer and may be changed if necessary. The fund does not aim to reproduce the benchmark. The portfolio manager may invest at their own discretion in securities or industries not included in the benchmark in order to capitalise on specific investment opportunities. The investment strategy will restrict the extent to which the portfolio holdings may deviate from the benchmark. This deviation may be material. Income shall remain the fund (or: in this unit class) and shall increase the value of the units. In case of a conversion of the shares from one share class of the fund into another share class of this fund no additional charge will be levied. What happens if the Manufacturer is unable to pay out?

How long should I hold it and can I take my money out early?

Recommended holding period: 7 Years

This product does not have a mandatory holding period. The recommended holding period is based either on historical data or the Manufacturer's estimate regarding the average fluctuation in the unit value, which is to be expected for this product. If you, as an investor, have a shorter investment horizon, the risk is on average higher that at the time of redemption, the unit value of the product will be lower than when you invested. There are no redemption costs or fees. However, you may return the product in accordance with the procedures indicated in the Sales Prospectus.
