Objectives and Investment Policy

This Fund is actively managed. The benchmark MSCI China 10/40 (hedged in SGD) (NR) is used for performance comparison only. The Fund is not benchmark constrained and its performance may deviate significantly from that of the benchmark.

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by Chinese, Hong Kong or Taiwanese companies, or companies operating in those countries.

It may be invested in Mainland China shares restricted to foreign investors such as China A shares which can be listed on a Stock Connect or through a use of a specific license (RQFII) granted by the Chinese authorities.

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria in the investments of the Fund.

A dividend is distributed on a monthly basis.

Investors are able to redeem on a daily basis (on Luxembourg bank business days), except if the Shanghai and Shenzhen stock exchanges are closed. This share class aims at hedging the portfolio return from USD to SGD.
