#### **Objectives and investment policy**

The fund is actively managed. The fund is managed in reference to a benchmark. The objective of the investment policy is to achieve sustained capital appreciation that exceeds the benchmark (BarCap Pan-European Aggregate). To achieve this, the fund invests in European government bonds, corporate bonds and covered bonds. Emerging-market bonds may be added. The selection of the individual investments is at the discretion of the fund management. In addition to financial strength, there is also a focus on environmental and social aspects and the principles of good corporate governance ("ESG criteria") when selecting investments. The majority of the fund's securities or their issuers are expected to be components of the benchmark. The fund management will use its discretion to invest in e.g. securities, sectors, ratings that are not included in the benchmark in order to take advantage of specific investment opportunities. It is expected that the portfolio will have a similar weighting to the benchmark. The positioning of the fund can deviate from the benchmark to a limited extent (e.g., by holding positions that are not contained in the benchmark, as well as by an underweighting or overweighting). The actual leeway in this respect is normally relatively low. Despite the fact that the fund aims to outperform the benchmark, the potential outperformance might be limited depending on the prevailing market environment (e.g. less volatile market environment) and actual positioning versus the benchmark. The fund distributes annually. You may request the redemption of shares generally on a daily basis. The Company may, however, suspend or restrict the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors.


