## What is this product?

### Type

The product is a UCITS - Special property in accordance with German authorization.

#### Term

This product is an open-ended fund without predefined maturity. For information on redemption possibilities please refer to section "How long should I hold it and can I take out my money early?". The Company may, however, terminate its right to manage the fund by giving a minimum of six months' notice by way of an announcement in the Bundesanzeiger and additionally in the annual report or semiannual report. The RC share class of DeAM-Fonds BKN-HR was launched in 1981.

### **Objectives**

The fund is actively managed. The fund is not managed in reference to a benchmark. The fund's primary investment objective is to avoid risk, while at the same time achieving a reasonable annual distribution of income. In order to achieve this, the fund invests in bonds and securities that grant rights to creditors (together: interest-bearing securities) from issuers whose registered office is in a member country of the European Union, Iceland, Norway, Liechtenstein, Switzerland and in securitized financial instruments. The fund may invest over 35% of assets under management in bonds of diverse public issuers. The bonds held for the account of the investment fund must consist of at least six different issues; no more than 30% of the fund volume may be invested in one issue. Assets denominated in a currency of a member country of the European Union besides the euro may only be acquired in connection with a hedging transaction. Up to 49% of the value of the fund may be invested in bank balances and money market instruments. Investment fund units may not be acquired and borrowings may not be undertaken. Derivative financial instruments may only be used for hedging purposes. The selection of individual investments is at the discretion of the fund management. The return of the product can be derived from the share price that is calculated daily plus any destribution. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. More share classes may be available for this fund - please refer to the relevant section of the prospectus for further details. The depositary is State Street Bank International GmbH, Germany. ### Intended retail investor

The fund is aimed at professional investors with a medium-term investment horizon and basic knowledge/experience and who can bear a financial loss. The fund can be used for general asset accumulation.

# What happens if DWS Investment GmbH is unable to pay out?

The assets of the fund are kept separately from the own assets of the management company DWS Investment GmbH. Investors of the fund cannot suffer any financial loss as a result of this separation due to a failure of the management company. In the event of a default by the depositary State Street Bank International GmbH, Germany, investors of the fund may suffer a financial loss if their deposits are not covered by the Deposit Guarantee Fund of the Bundesverband deutscher Banken e.V.. If deposits on the fund are made with other credit institutions, investors may also suffer a financial loss, provided that such deposits are not covered by any existing deposit guarantee schemes. The protection of deposits of the fund may also be limited in the case of existing deposit guarantee schemes, as they regularly have restrictions on the coverage of deposits in accordance with their statutes.
