What is this Product?

The Product is a sub-fund of EDMOND DE ROTHSCHILD FUND, a public limited liability company (société anonyme), incorporated as a "société d'investissement à capital variable" under Part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment and qualifying as an undertaking for collective investment in transferable securities (UCITS)

Objectives

Objective: The Product's investment objective is to outperform its benchmark of the Product's capital by investing its assets in equities of companies that meet environmental, social and governance (ESG)

Objective: The Product's investment objective is to outperform its benchmark of the Product's capital by investing its assets in equities of companies that meet environmental, social and governance (ESG) criteria, and whose activities are predominantly linked to China.

Benchmark index: The benchmark index of the Product is the MSCI China 10/40 Net Return Index, calculated with net dividends reinvested

The benchmark index serves only for comparison purposes. The Product is actively managed.

Investment policy: The Product aims selecting Chinese companies, with a focus on a good management of environmental, social and governance (ESG) risks and opportunities. The Product's investment process entails, to this aim, a proprietary responsible investing approach which favours ESG well rated companies irrespective of their capitalizations.

At least 90% of the companies in the portfolio will have an ESG rating.

The selection process includes a positive screening by selecting through a best in universe approach and a negative screening, whereby the Investment Manager has established a formal exclusion policy that integrates the exclusion of controversial companies related to weapons, coal and tobacco. The eligible investment universe is consequently reduced by 20% and defined according to ESG criteria. The Product Classifies as Article 8(1) SFDR as it promotes a combination of ESG characteristics, although no reference benchmark has been designated for the purpose of attaining the environmental or social characteristics.

In view of its ESG strategy, the Product promotes environmental characteristics but does not invest in environmentally sustainable economic activities. The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities, in the context of the Taxonomy Regulation.

The investment strategy is based on the selection and dynamic management of securities of companies that carry out most of their business in China. Between 75% and 110% of the Product's net assets will be exposed to equitities and other similar securities traded on regulated markets of companies listed, headquartered or with main business in China. The Product will invest in China A Shares via the Shanghai-Hong Kong Stock Connect program and in China B Shares listed on the Shanghai and Shenzhen stock exchanges and in equity securities listed on other stock exchanges such as Hong Kong, New York, Singapore and Taipei. Assimilated securities are ADR (American Depositary Receipts), GDR (Global Depositary Receipts), P-Notes (Participatory Notes) (except P-Notes having China A shares held via QFII quotas as underlying assets) and certificates of participation.

The scope of securities in which the Product invests will be focused, but not limited to, equities of companies whose capitalisation is greater than USD 500 million, covering all sectors. The sectorial diversification of the Product helps to limit the portfolio's volatility.

For cash management purposes, the Product may invest up to 25% of its net assets in transferable debt securities, Money Market Instruments, term deposits and Money Market Funds.

The Product may use financial derivative instruments to achieve its investment.

The actual risk can vary significantly if you cash in at an early stage and you may get back less. In addition, you will be exposed to the following risks (not captured in the synthetic risk indicator),

Credit risk: When a significant level of investment is made in debt securities.

<u>Liquidity risk</u>: The markets for some securities and instruments may have limited liquidity. This limited liquidity could be a disadvantage to the Product, both in the realisation of the prices quoted and the execution of orders at desired prices.

Impact of techniques such as derivative contracts: The use of derivatives instruments can infer a decrease of the asset more significant than the decrease of the invested underlying assets or markets.

<u>Counterparty risk</u>: Where a Product is backed by collateral or has significant investment exposure through contracts with a third party.

Recommended holding period: 5 years

Orders must be received by the transfer agent no later than 4:30 p.m. (Luxembourg time) on the relevant Valuation Day.
