Objectives and Investment Policy

Franklin High Yield Fund (the "Fund") aims to earn high income and, secondarily, to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

 debt securities of any quality (including lower quality debt such as noninvestment grade securities) issued by corporations, especially those located in the U.S.

The Fund can invest to a lesser extent in:

• other types of securities, including equity securities and government debt obligations

- derivatives for hedging and investment purposes \cdot securities in default (limited to 10% of assets)

The investment team manages risk through credit analysis of securities issuers, which involves a detailed examination of individual companies and specific industries.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

The benchmark of the Fund is the ICE BofA US High Yield Constrained Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. Terms to Understand

Debt securities: Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Equity securities: Securities that represent an ownership stake in a company.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Securities in default: Debt securities whose issuer condition has become uncertain and whose issuer is failing to make principal or interest payments when due.


Charges
