What is this product?

Type

The product is a share class of the sub-fund Franklin U.S. Dollar Short-Term Money Market Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund aims to preserve capital while seeking to maximize its investment return in US dollar over the short term. The Fund qualifies as a short-term variable net asset value money market fund under the European Money Market Fund Regulation.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in high-quality Money Market Instruments such as:

- short-term debt securities of superior quality issued by governments, government-related entities and corporations
- commercial paper issued by first-rate companies
- · certificate of deposit of prime banks

The Fund can invest to a lesser extent in:

- repurchase/reverse repurchase agreements
- · eligible securitisation and asset-backed commercial paper
- deposits and ancillary liquid assets
- \cdot units or shares of other short-term Money Market Fund (less than 10% of the Fund's assets)

The Fund invests only in securities that are denominated in US dollar with an average maturity not exceeding 397 days.

The benchmark of the Fund is the Bloomberg US Treasury 1-3 Month Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

Intended retail Investor

The Fund may appeal to investors looking to capital preservation and income by obtaining exposure to high-quality USD-denominated debt securities and money market securities issued by governments and corporations worldwide and willing to hold their investment over the short term for a period of 1 to 3 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 1 year(s).

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- USD 10,000 is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 0.7% before costs and -0.6% after costs.

Recommended holding period: 1 year(s)

This Fund has no minimum required holding period. We consider that the 1 year recommended holding period is appropriate because the Fund is designed for short-term investment.
