# **Objectives and Investment Policy**

#### **Investment Objective:**

The Fund aims to provide long term capital growth and income by investing in a portfolio of shares.

The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. More information on HSBC Global Asset Management's responsible investing policies is available at www.assetmanagement. hsbc.com/about-us/responsible-investing/policies.

#### Investment Policy:

In normal market conditions, the Fund will invest at least 70% of its assets in shares (or securities similar to shares) of companies of any size that are based in, or carry out the larger part of their business activities in developed markets and emerging markets with revenue exposure to Climate Transition Themes.

Climate Transition Themes may include but are not limited to, renewable energy, energy efficiency, clean transportation and green buildings. They are proprietary to HSBC, determined with reference to the eligible activities of the Green Bond Principles of the International Capital Market Association and the Climate Bonds Taxonomy of the Climate Bonds Initiative.

The Fund will not invest in shares of companies considered non-compliant with the United Nations Global Compact Principles. The revenue exposure threshold will depend on the specific excluded activity but will not be higher than 30% of the relevant company's total revenue.

After identifying the eligible investment universe, a portfolio is constructed with lower carbon intensity and higher ESG rating, calculated respectively as a weighted average of the carbon intensities and ESG ratings given to the issuers of the Fund's investments, than that of the MSCI AC World Net index.


When assessing companies' carbon intensity, ESG rating and revenue exposure to an excluded activity, the Investment Adviser may rely on expertise, research and information provided by well-established

financial data providers. Please refer to the prospectus for further details on Climate Transition Themes and Excluded Activities.

The Fund may invest up to 20% in China A and China B-shares. For China A-shares, up to 10% through the Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect, up to 10% in CAAPs and up to 10% in CAAPs issued by any single issuer. The Fund may invest up to 10% of its assets in Real Estate Investment Trusts (REITs), up to 10% in other funds and may invest in bank deposits, money market instruments for treasury purposes. The Fund may also invest in derivatives and use them for hedging and cash flow management purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is MSCI AC World Net.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

# Material risks not fully captured by the Risk and Reward Indicator:

 Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.



#### Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between subfunds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other subfund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 08 February 2024.
