This document provides you with key investor information about this fund. It is not marketing material. ## Lyxor Smart Overnight Return - IE (the "Fund")

ISIN: LU1190418134 - A sub-fund of the investment company named Lyxor Index Fund (the "Company") domiciled in Luxembourg. Managed by Lyxor International Asset Management S.A.S. ("LIAM")

## Objectives and investment policy

The Fund is an active UCITS.

The investment objective of the Fund is to generate a return linked to money market rates. The Fund is benchmarked with the €STR compounded rate ("Benchmark Index"). The Fund is actively managed by investing in a diversified portfolio of financial instruments within a strict risk and liquidity control environment. The majority of the Fund's investment or exposure are linked to the Benchmark Index. The Fund's investment strategy is linked to the Benchmark Index, any deviation from the Benchmark Index is limited.

The €STR (Euro Short-Term Rate) reflects the wholesale euro unsecured overnight borrowing costs of banks located in the euro area. €STR uses transaction data from daily currency exchange reports produced by the 52 largest banks in the euro area. It is the average interest rate on loans made during the day.

The daily compounded €STR is calculated and published by the ECB. The €STR is published on each business day based on transactions conducted and settled on the previous business day (the reporting date "T") with a maturity date of T+1 which are deemed to have been executed at arm's length and thus reflect market rates in an unbiased way.

The Fund does not benefit from any implicit or explicit guarantee, neither from a swap counterparty nor from any entity acting as distributor of the Fund.

The €STR reference rate may be negative, which could result in a negative performance of the Fund.

The share currency is the Euro (EUR).

- **Invested financial instruments:** to achieve its investment objective, the investment universe of the Sub-Fund consists of : - Money market instruments including cash deposits with credit institutions, - Transferable securities (including equities, debt instruments with fixed or variable coupon) or units or shares of UCITS authorized in accordance with the UCITS Directive, - Financial derivative instruments including in particular: Money market swaps, currency forwards and currency swaps transactions strictly designed to hedge currency risks and interest rate swaps transactions aiming at reducing interest rate risks.  
- Efficient portfolio management techniques including: securities lending and borrowing of securities, repurchase and reverse repurchase transactions on transferable securities (including equities, fixed or variable debt instruments).  
The Sub-Fund may also hold cash.
- **Dividend policy:** all the Fund's amounts available for distribution (if any) shall not be distributed to Shareholders, but reinvested.
- **Net Asset Value:** The Net Asset Value per share is calculated on each Valuation Day.
- **Redemptions:** redemption requests shall be received at or before 13:00 Europe/Luxembourg Time each Valuation Day (D). More details are available in the Fund's prospectus.

## Risk and reward profile



The risk-return category shown above is based on the historical performance of the assets included in the Fund or the performance of its benchmark index or the computed performance of a portfolio model. This risk estimate may therefore not represent a reliable indicator of future risk, and may be subject to change over time. The lowest category does not mean risk free investment. The Fund has been classified within category 1. Category 1 indicates that a capital loss is possible but extremely unlikely under normal market conditions.

Main risks not covered by the above indicator which could lead to a decrease in the net asset value of the Fund and which the Fund is authorized to disclose in this document (for more details about risks, please refer to the Risk Profile section of the prospectus):

- **Counterparty risk:** The Fund is exposed to the risk that any counterparty with which it has concluded an agreement or a transaction could become insolvent or otherwise default and more particularly when it has concluded financial derivative instruments over-the-counter or securities lending transactions. If such an event occurs, the net asset value of the Fund may decrease significantly. According to the regulation applicable to the Fund, such risk cannot exceed 10% of the Fund's total assets per counterparty.
- **Risk of Financial derivative Instruments:** The Fund invests in financial derivative instruments. These financial derivative instruments can induce different types of risks such as (but not limited to) leverage risk, high volatility risk, valuation risk or liquidity risk. If this risk occurs, the net asset value of the Fund may decrease significantly.
- **Operational risk:** In the event of an operational failure of the management company or one of its representatives, investors could experience loss, delay in processing subscriptions, conversions, redemptions orders or other type of disruptions.
- **Credit risk:** The Fund is subject to the risk that any issuer could become insolvent or to otherwise event having an impact on the credit quality of this issuer. The consequence of this risk or event may result in a decrease of the net asset value of the Fund.

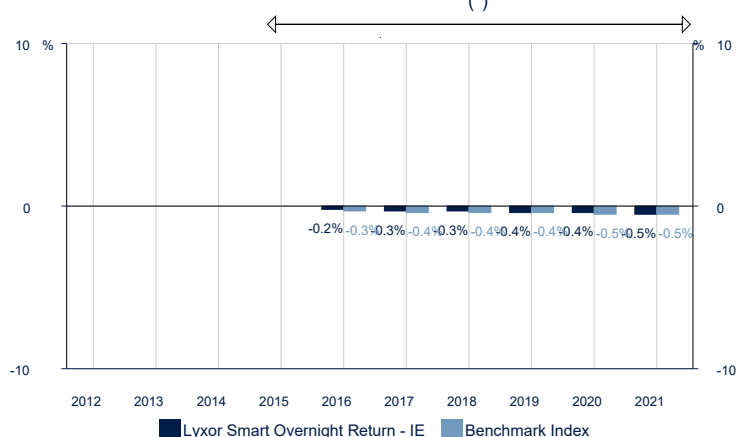
## Charges for this Fund
