### Objective and investment policy

The fund aims to provide a combination of capital growth and income to deliver a return that is higher than that of the global emerging markets stockmarket over any five-year period

**Core investment:** At least 80% of the fund is invested in the shares of companies that are based, or do most of their business, in emerging markets. The fund may invest in China A-Shares via the Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect.

**Other investments:** The fund may invest in other funds and cash or assets that can be turned quickly into cash.

**Derivatives:** The fund may use derivatives to reduce the risks and costs of managing the fund.

**Strategy in brief:** The investment manager selects stocks using a bottom-up approach across a range of sectors. A long-term perspective is adopted to identify companies whose long-term prospects are, in the investment manager's opinion, being undervalued. It is the core belief of the investment manager that corporate governance and company-specific factors, in particular their profitability (which is measured in terms of return on capital), drive share prices over the long run. The fund's country and sector exposure is not influenced by top-down views.

#### Benchmark: MSCI Emerging Markets Net Return Index

The benchmark is a comparator against which the fund's performance can be measured. It is a net return index which includes dividends after the deduction of withholding taxes. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed. The investment manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

For unhedged and currency hedged share classes, the benchmark is shown in the share class currency.

#### Other information

You can buy and sell shares in the fund on any business day. Instructions received before 13:00 Luxembourg time will be dealt at that day's price.

Any income from the fund may be paid out to you annually.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These may have a material impact on your returns.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

#### The main risks that could affect performance are set out below:

- The fund may invest in China A shares. Investments in assets from China are subject to changeable political, regulatory and economic conditions, which may cause difficulties when selling or collecting income from these investments. In addition, such investment is made via the Stock Connect system, which may be more susceptible to clearing, settlement and counterparty risk. These factors could cause the fund to incur a loss.
- In exceptional circumstances where assets cannot be fairly valued, or have to be sold at a large discount to raise cash, we may temporarily suspend the fund in the best interest of all investors.
- The fund could lose money if a counterparty with which it does business becomes unwilling or unable to repay money owed to the fund.
- Operational risks arising from errors in transactions, valuation, accounting, and financial reporting, among other things, may also affect the value of your investments.

The above ongoing charge figure is an estimate of the charges because of a change to the charging structure with effect from 1st October 2020.

The audit fees and custody transaction charges are borne by M&G until the fund size increases to above 200 million euros. The fund's annual report for each financial year will include details on the exact charges made.

For Distribution shares, the ongoing charge is taken from investments held in the fund's portfolio and not from the income these investments produce. The deduction of this charge will reduce the potential growth of your investment.
