You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

- **Type:** The product is a Sub-fund of Mediolanum Best Brands (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a UCITS pursuant to the provisions of the UCITS Regulations and governed by Irish law.
- **Term:** This is an open ended fund with no maturity date.
- · Objectives:
 - The Sub-Fund's objective is to achieve medium long term capital growth.
 - The Sub-Fund invests primarily in US, European and emerging market low rated fixed income securities (such as bonds issued by companies or governments).
 - The fixed income securities invested in may be rated investment grade (by a generally recognised international rating agency), below investment grade or unrated.
 - The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management, hedging and/or direct Investment purposes.
 - The Sub-Fund may enter into securities lending transactions.
 - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
 - The Manager has flexibility to change the Sub-Fund's asset allocation (% of the portfolio invested in bonds/FDIs etc) at any time and has discretion to select investments within each asset class.
 - The product is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
 - FDIs are used to remove the impact of exchange rate movement (hedging) which may affect the value of this Class of Unit.
 - o Income and gains generated by the unit class will be distributed periodically in the form of a dividend.

What are the risks and what could I get in return?

How long should I hold it and can I take money out early?

Recommended holding period: 5 years
