# "I Class Income Units", a unit class of Preferred Securities Fund (the Fund), a subfund of Principal Global Investors Funds (the Trust) (ISIN: IE00B96S2C60)

This Fund is managed by Principal Global Investors (Ireland) Limited (the Manager), part of The Principal Financial Group of companies

#### Objectives and investment policy

The overall objective of the Fund is to provide a return consisting of income consistent with capital preservation.

The Fund seeks to achieve its overall objective by investing primarily in a portfolio of US dollar denominated preferred securities and debt securities, including convertible bonds and contingent convertible securities (CoCos). At the time of the Fund's investment, the majority of these securities will be rated as investment grade quality. The Fund's investments will be offered on markets listed worldwide, although it is anticipated that the majority will be issued by US and / or European issuers.

This Fund is classified as an ESG Orientated Fund (as defined in the Prospectus). The environmental characteristics considered by the Fund include, but are not limited to, greenhouse gas emissions reduction and transitioning to renewable sources of power. The social characteristics considered by the Fund include, but are not limited to, health and safety and product safety.

The Fund seeks to add value primarily through security selection, including credit analysis. Its investment process involves in depth proprietary research, and strategic and disciplined portfolio construction.

The Fund may also hold ancillary liquid assets such as bank deposits. However, no more than 1/3 of the net assets of the Fund may be held in aggregate in ancillary liquid assets or non-preferred or debt securities or instruments.

While it is generally intended for the Fund to be fully invested at all times, there may be a portion of assets held in cash or deposits at any given time.

Any income received by the unit class will be reinvested.

You may buy or sell units on demand on each Dealing Day being a Business Day as defined in the Fund's supplement (which together with the prospectus constitutes the Prospectus).

The Fund is actively managed and aims to outperform the Bloomberg Barclays Global Aggregate Corporate USD TR (the "Index"). However, the Index composition is not factored into the investment management process and the portfolio manager maintains full discretion to select investments for the Fund in line with the above investment policy.

#### Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.



This Fund is ranked at 4 because funds of this type have experienced average rises and falls in value in the past.

The following are risks materially relevant that are not captured by the SRRI:

- There may be risks associated with investment in Contingent convertible securities due the unpredictable nature of conversion events and the higher credit risk of subordinated instruments.
- The market value of debt securities is affected by changes in prevailing interest rates. The Fund may also be exposed to credit and default risk by investing in such securities. The default risk increases for below investment grade debt securities.
- There are specific risks associated with investments in emerging markets, resulting from potentially less developed market practices. These include legal, political and fiscal instability, settlement, liquidity, currency, accounting standards and custodial risk.
- The Manager integrates sustainability risks into the investment processes for the Fund in relation to risk management and decision making. This means ESG factors are considered as part of the investment process which may carry the risk that the Fund's performance may be negatively impacted due to restrictions placed on its exposure to certain sectors or types of investments as a result.
- The value of an investment may fluctuate due to changes in exchange rates between currencies and may or may not be hedged back to the Fund's base currency.
- Fees and/or distributions may be paid out of the capital of the fund, which has the effect of lowering the capital value of investors' holdings in the fund and limiting the potential for future capital growth.


Ongoing charges are based on the last year's expenses, for the year ending December 2022, and this figure may vary from year to year. It excludes:

- Whereas the entry charge will not normally be made on a conversion, the Manager is entitled to make any such charges at its discretion. In particular, if more than four conversions are made during a twelve month period, the Manager may impose a service fee for any subsequent conversions during the subsequent twelve month period.
