What is this product?

Type: Shares of Private Banking Vermoegensportfolio Nachhaltig 50, an undertaking for collective investment in transferable securities (UCITS), established as an investment fund.

This is a UCITS investment fund established in Germany. The Private Banking Vermoegensportfolio Nachhaltig 50 investment fund is a collective investment undertaking which collects capital from a number of investors in order to invest it in accordance with a defined investment strategy for the benefit of these investors.

Term: The term of the Fund is open-ended. The Management Company may terminate the Fund by dissolution or merger with another fund, in accordance with the legal provisions.

Objectives: The aim of Amundi Fund Management and investment advice provided by Hypo-Vereinsbank/UniCredit Bank AG is to allow investors to participate in the development of the international capital markets and to achieve a better performance than the benchmark in the long term. The investment markets are invested in via permitted assets in accordance with the investment conditions. The investments are actively managed.

The Fund is classified in accordance with Article 8 of the Disclosure Regulation, i.e. it pursues an investment policy aligned with ESG criteria.

To achieve its objective, the Fund aims to invest no more than 50% in:

- equity funds whose risk profile correlates with equity markets;
- equities, participation certificates, convertible bonds;
- exchange-traded funds, index-oriented funds, each representing the performance of equity indices;
- certificates on equities, equity-like securities.

The Fund may also invest in asset classes, currencies, regions and assets outside the benchmark and may use derivative transactions for hedging, speculative purposes and efficient portfolio

management. The Fund invests primarily in assets of issuers with sustainable business practices or assets based on sustainable indices or sustainable investment strategies.

In addition, the Fund may invest in accordance with the "General and Special Conditions of Investment". The Fund includes sustainability criteria in its investment process based on an investment universe created by Institutional Shareholder Services Germany AG.

The Fund does not track a securities index. For the Fund, the company uses a benchmark of 5.7% on the MSCI AC Asia Pacific, 19.3% on the MSCI Europe, 10.7% on the MSCI North America, 47.6% on the iBoxx € Germany 1–10 Total Return Index, 12.9% on the iBoxx USD Treasuries 1–10Y Total Return and 3.8% on the Gold Bullion LBM U\$/Troy Ounce.

Intended retail investors: This product is intended for investors with a basic knowledge and with no or limited experience of investing in funds, seeking to increase the value of their investment over the recommended holding period and who are able absorb losses up to the investment amount.

Redemption and dealing: Shares may be sold (redeemed) as stated in the prospectus and investor information document at the respective dealing price (net asset value), subject to suspension of redemption by the Management Company owing to extraordinary circumstances. Distribution policy: The Fund income is ordinarily distributed.

What are the costs?
