What is this product?

This is an open ended UCITS fund.

Term

There is no maturity date of the fund.

Investment objective

The fund aims to provide a positive return after fees have been deducted over a three year period by providing exposure to insurance risks that meet the manager's sustainability criteria.

The fund is actively managed and will invest globally in a diversified portfolio providing exposure to insurance risks. These include insurancelinked securities and financial derivative instruments that are exposed to catastrophe risks denominated in various currencies.

The fund invests:

- at least 80% of its assets in investments linked to natural catastrophe and/or life risks;

- at least 50% of its assets in investments linked to meteorological risks;
- at least 5% of its assets in investments that are designed to address the

unavailability of affordable insurance cover against natural catastrophes. The fund may hold cash (subject to the restrictions provided in appendix I in the fund's prospectus) and invest in money market investments and liquid assets other than cash. The fund will not invest more than 10% into funds.

The fund maintains a positive absolute sustainability score, based on the manager's rating system.

The fund does not directly invest in certain risk classes, activities, industries or groups of issuers above the limits listed under "Sustainability-Related Disclosure" on the fund's webpage, accessed via www.schroders.com/en/lu/private-investor/gfc.

The fund invests in investments issued by issuers that have good governance practices, as determined by the manager's rating criteria. The

manager may also engage with issuers or transaction sponsors held by the fund to challenge identified areas of weakness on sustainability issues. More details on the manager's approach to sustainability and its engagement with companies are available on the website:

Recommendation: Investors should seek independent advice and satisfy themselves that they have an understanding of the techniques employed by the investment manager.

The fund is valued with reference to the net asset value of the underlying assets.

Benchmark: The fund's performance should be assessed against its target benchmark, being to provide a positive return over a three year period. The target benchmark has been selected because the target return of the fund is to deliver the return of that benchmark as stated in the investment objective. The investment manager invests on a discretionary basis and is not limited to investing in accordance with the composition of a benchmark.

Dealing Frequency: You can buy and sell shares fortnightly on the 2nd and 4th Friday in a month (or the next business day if the Friday is not a business day) and on the last business day in a month.

Distribution Policy: This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.



*This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 4,1 % before costs and 2,2 % after costs.

We have classified this product as 3 out of 7, which is a medium-low risk class.

The fund is in this category because it seeks to provide rewards whilst limiting price volatility.

Liquidity risk: In difficult market conditions, the fund may not be able to sell a security for full value or at all. This could affect performance and could cause the fund to defer or suspend redemptions of its shares, meaning investors may not be able to have immediate access to their holdings.
