The fund aims to provide capital growth and income.

Investment Policy

At least two-thirds of the fund (excluding cash) will be invested in bonds issued by governments, government agencies and companies worldwide in various currencies (which may include asset backed and mortgage backed securities).

The fund manager, supported by Schroders' global fixed income investment team, seeks to identify bonds issued mainly by governments or companies within emerging markets which offer the best possible risk/reward profile. Investing on a global basis allows investors to benefit from the best opportunities available around the world, and does not limit the fund manager to a single region or market.

The fund may also invest in other financial instruments and hold cash on deposit. Derivatives may be used to achieve the invest-


