Objectives and Investment Policy


SEB Corporate Bond Fund EUR aims to create capital growth in the long term. This fund is actively managed and focuses on Europe. The fund's manager seeks to outperform the return of the Barclays Capital Corporate Bond Index EUR (a European corporate bond index).

The main category of financial instruments are corporate bonds but also governement bonds and other debt instruments issued by companies, governments and mortgage institutions with a minimum credit rating of BBB- (on Standard & Poor's scale) or equivalent. The average maturity of the fund may vary from 3 to 6 years. Derivatives are used to achieve the investment objectives and facilitate the management of the fund. The fund manager also uses derivatives to minimize the effects of foreign exchange rate fluctuations on the fund's performance.

Generally, investors can buy or sell units of the fund on any bank business day in Luxembourg and Sweden. Income of the fund is distributed.

Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within 3 year(s).

Risk and Reward Profile



The risk and reward indicator illustrates the relationship between risk and return for the fund. The higher the fund is positioned on this scale, the greater the possible reward, but also the greater risk of losing money. Category 1 does not mean that the investment is risk free.

The risk category has been calculated using historical performance data which may not be a reliable indicator of the fund's future risk and reward profile.

This fund is in category 3. This means that the risk for value changes in the fund is medium. This category may change over time.

The following risks are not fully reflected in the above classification but still influence the fund's value:

Credit risk - the fund invests directly or indirectly in bonds or other fixed income related instruments. If an issuer of a bond fails to pay the interest and principal amount on time, the bond could lose up to its entire value.

Counterparty risk - if a counterparty does not fulfill its obligations to the fund (e.g. not paying an agreed amount or not delivering securities as agreed).

Liquidity risk - some of the assets of the fund may become difficult to sell at a certain time and for a reasonable price.

Operational risk - the risk of loss resulting from e.g. system breakdowns, human errors or from external events.

Currency risk - the fund invests in securities that are issued in currencies other than the base currency of the fund. As a result the fund is subject to currency risk, which arises from changes in the exchange rates.



In case of suspicion of market timing, up to 2.00% may be charged at the discretion of the Management Company.

The ongoing charges figure is based on expenses for the year ending 2011. This figure may vary from year to year. Performance fees and portfolio transaction costs are not included in the ongoing charges figure, except for portfolio transaction costs for entry/exit charges paid by the fund when buying or selling units in another fund.
