# What is this product?

#### Type

This product is a sub-fund of SEB Fund 5, a Luxembourg open-ended common fund (FCP) with multiple sub-funds, which qualifies as a UCITS.

#### **Term**

The fund has no maturity date. The management company has the right to terminate the fund, more information can be found in the fund's prospectus.

#### **Objectives**

**Investment objective** The fund aims to increase the value of your investment over time and to outperform its benchmark.

**Investment policy** The fund is actively managed and invests primarily in Danish covered mortgage bonds and in some part, government bonds in the Danish fixed-income market.

The fixed-income securities that the fund invests in are denominated in a currency of the European Economic Area or in Swiss Franc, and have a high credit rating, a minimum of BBB- on Standard & Poor's scale, or the equivalent. Investment decisions are based on in-depth (fundamental) analysis, where future cashflows are estimated based on different scenarios to select securities that appear to offer a favourable risk-adjusted return. The return is determined by how much the fund's holdings increase or decrease in value during your holding period, which is mainly dependent on interest rates and the impact of future interest rate developments on the fund's various fixed-income securities, primarily based on maturities and creditworthiness.

The fund promotes sustainability characteristics and is therefore classified as Article 8 according to the EU Sustainable Finance Disclosure Regulation (SFDR). The fund follows the management company's sustainability policy, which is available at www.sebgroup.lu/funds.

**Benchmark** 60% Nykredit Danish Mortgage Bond Index, 25% Bloomberg Series E-Denmark Govt All > 1 Yr Bond Index and 15% Nykredit Constant Maturity 3Y Non-callable Index

We compare the fund's return to 60% Nykredit Danish Mortgage Bond Index, 25% Bloomberg Series E-Denmark Govt All 1 Yr Bond Index and 15% Nykredit Constant Maturity 3Y Non-callable Index. The fund uses the benchmark for portfolio reference and performance comparison. The majority of the fund's holdings are components of the benchmark, but they differ in weight. The management of the fund is discretionary, and the investment strategy does not aim to restrict how much the fund's holdings deviate from its benchmark.

**Subscription and Redemption** You can normally buy and sell units in the fund every Luxembourg bank business day, except December 24 and 31.

Minimum initial investment: 1,000,000 EUR **Distribution Policy** The unit class is distributing.

#### Intended retail investor

This fund may be suitable for you who intend to keep your investment for at least 3 year(s), and who understands that the money invested in the fund can both increase and decrease in value. It is therefore not certain that you will get back all the invested capital. In order to invest in the fund, it is not required that you have any special prior knowledge or experience of mutual funds or financial markets. This share class is intended for institutional investors.



# What are the risks and what could I get in return?

#### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 2 out of 7, which is a low risk class. This means that the fund has a low risk of increases and decreases in the share value. The indicator primarily reflects the increases and decreases of the asset classes in which the fund has invested.

Be aware of currency risk if you invest in a share class denominated in a currency that is different from the official currency of the country where the share class is being marketed. You will then receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment.

### Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

**Unfavourable**: this type of scenario occurred for an investment in the product or a suitable benchmark between 30 September 2019 and 30 September 2022.

# What happens if SEB Investment Management AB is unable to pay out?

According to law, the fund's assets may not be stored by the management company. Instead, each fund must have a specific depositary that takes care of the safekeeping of the fund's assets. In the unlikely event that the management company goes bankrupt, the management of the fund is taken over by the depositary. There is no arranged compensation or guarantee scheme for investors in the fund.

### What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is included as part of another product, e.g. unit linked insurance, there may be other costs for that product.

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the product's recommended holding period we have assumed the product performs as shown in the moderate scenario.
- 10,000 EUR is invested.

(\*) This illustrates how costs reduce your return each year over the holding period. # How long should I hold it and can I take money out early?

Recommended holding period: 3 year(s)

The fund has no requirement for a minimum holding period, but since it invests in fixed income, it is suitable for a short to medium term investment horizon. You should be prepared to hold your investment in the fund for at least 3 year(s). You normally have the opportunity to sell your fund units every bank business day in Luxembourg except December 24 and 31 without any extra fee.
